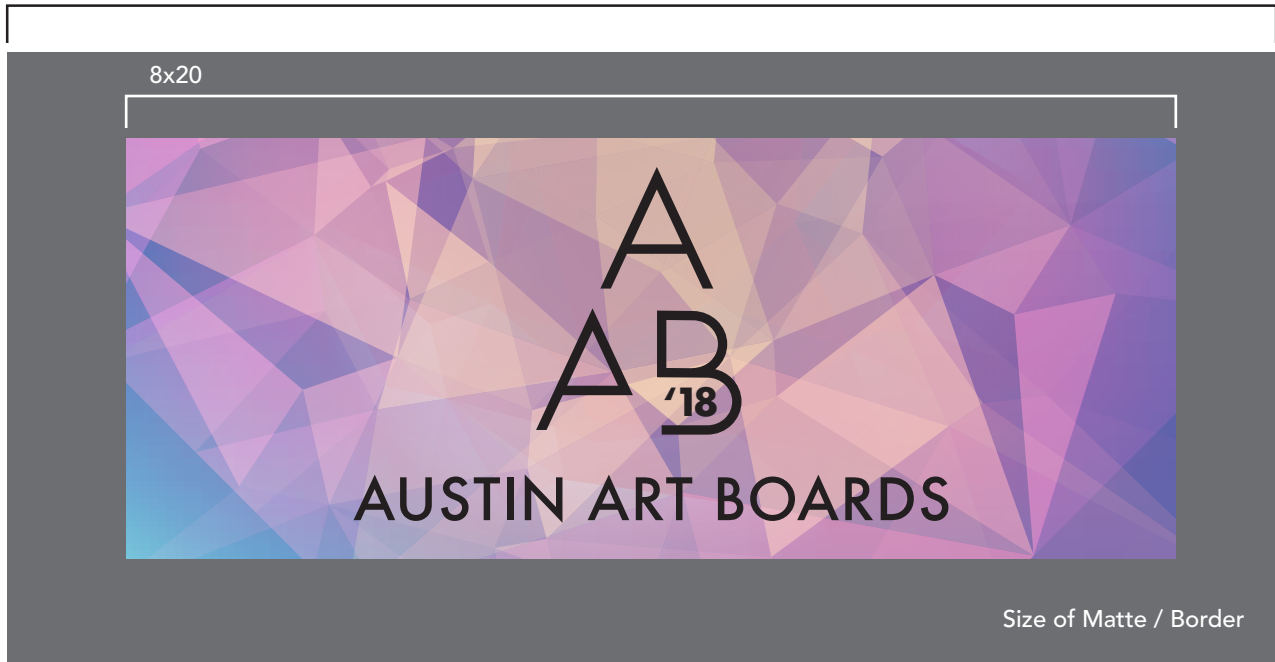

# Program Guidelines

•**FREE to enter. Open to all ages. One entry per person. However all entries must be submitted as hard copies. (Printed or produced). We strongly encourage you to have a print made of your work for submitting rather than entering the original art in order to be safe in the rare instance that it gets damaged during transport.**

•Artwork must be submitted, sized to 8"x20". Art submitted out of scale will not be eligible for entry. Submitted art must be matted in black or white matte board 2 inch border (matte sized to 12"x24"). Digital files may be submitted at 300 dpi .Jpg or .Tif formats to Skyline Prints.

•All types of artwork will be eligible, including collage, mixed media, photo, \*ceramic,(in 2D) sculpture et al.

•All "placing" entries will be scanned and displayed on the website: AustinArtBoards.org as well as the Facebook page.

•Artwork must be the original creation of the submitting artist.

•Applicants must reside in Travis, Williamson, or Hays counties.

•To insure impartiality, artists names should not appear on the artwork, but rather affix the detachable form enclosed in this sheet. The finished billboard art, will include an area designated for name and title of piece. Winning artists will receive a proof of their work as it will appear on the board.

•Eligibility: Direct family members of judging panel, board of directors and employees of Reagan Outdoor are NOT eligible to participate. 2017 Winners may not participate in Austin Art Boards, 2017 Honorable mentions still eligible.

•Be mindful of the medium. Winning pieces will be selected based on their creativity, but also on their functionality on billboard space. Good contrast, simplicity and vibrancy should be considered when creating their work, but remember, this is Art not an Ad. Sculpture and 3D pieces may be submitted as photographs sized to 8"x20"

•Entrants agree to provide Reagan Outdoor the right to reproduce their work on either billboards or promotional material promoting the program. (See page two).



## AUSTIN ART BOARDS

•Following judging all work must be picked up from November 2 - December 14. Pickup location will be at Reagan Outdoor Advertising. 7301 Burleson Road, Austin, TX 78741.

•All entries must present a hardcopy print or production of their work. This is done to ensure all participants get an equal viewing size during the judging process.

•Artwork must be submitted by **Friday, September 28, 2018 by 4PM** to **Skyline Printing** (details below). Judging will occur in October by a panel of local judges. Artists will be notified by email or phone later that month. Winners will be posted by Winter 2018.

•Artwork must be picked up by December 14th, 2018. After that date, artwork will be discarded.

By submitting my artwork, I hereby agree to grant Reagan National Advertising and its subsidiaries the right to modify and distribute the art for any advertising and media related to promotion of the Austin Art Boards campaign. Reagan may use my art in billboards, social media, PR press releases, promotional videos, television, posters, and other printing or digital material related to Austin Art Boards.
4. I acknowledge and agree that Reagan National Advertising shall have no obligation to post, display or otherwise make publicly available any work submitted by myself, and may, in its sold and unfettered discretion, remove, edit, modify or delete any artwork that I submit.
